Mixed cases are not available unless otherwise stated, for example in a bin-end offer.

CANCELLATIONS & RETURNS

Once an order has been placed and confirmed either verbally, in writing or by email it is not possible to cancel the order and payment must be made in full according to the agreed terms.
If a wine is damaged in delivery, AFW will, where possible, replace the goods or offer a full refund in respect of the damaged goods only.
If incorrect goods are delivered AFW will either refund or replace the incorrect orders on return of the cases in question.
In the event that any of the above problems arise, please inform us as soon as possible.

TAX FREE ORDERS IN THE EU
